Dear Grant Manager Personnel:

NSF has just updated its post shutdown webpage with new information for delayed proposal deadlines.

In addition, NSF has provided the following guidance:

- 1) Delay in implementation of NSF's 2019 Proposal and Award Policy and Procedure Guide (PAPPG 19-1), originally to be effective on 1/28/2019. Until further notice, PIs should continue to follow PAPPG 18-1 for NSF's general instructions on proposal development.
- 2) Delay in implementation of NSF grant terms and conditions, originally to be effective 1/28/2019 (including Research Terms and Conditions, Grant General Conditions, Cooperative Agreement Conditions, and Special Conditions). Until further notice, PIs should continue to follow the existing terms and conditions referenced in each award.

Subject: Government Shutdown Impact on Federal Proposal Deadlines

Dear Grant Management Personnel:

The agencies that closed due to a lapse in appropriations (including NSF, NASA, Commerce and Interior) have been given a reprieve; however, the continuing resolution that allowed them to reopen will end on February 15th unless it is further extended or actual appropriations are enacted.

NSF has posted updated information on its website:

https://www.nsf.gov/bfa/dias/policy/postshutdown.jsp

The key point is that NSF will modify some deadlines as indicated on the site above, and that it will provide updated information by February 1. If any of your PIs intend to submit to these deadlines, please monitor this URL for updated information. NSF has also indicated that during this continuing resolution period it will give priority to issuing continuing grant obligations over issuing new awards.

NASA does not seem to have posted any general information, but with regard to proposal deadlines NASA has updated specific opportunities. For example, all deadlines under the ROSES-18 Research Announcement that were to have occurred before March 29, 2019 will be assigned new due dates, as indicated in Amendment 55 to the Announcement:
